Car accidents are a common occurrence in the United States. According to the National Highway Traffic Safety Administration (NHTSA), there were approximately 6.7 million police-reported crashes in 2018. If you are involved in a car accident, it can be a stressful and overwhelming experience.

Here are six important things you should do after a car accident:

- 1.** Call the police and get the police report number. Do not let the other people involved in the accident leave the scene until the police arrive.
- 2.** Do not move the vehicles until the police arrive and you are instructed to move them. The physical placement of the vehicles can be important in determining how the accident occurred.
- 3.** Take photographs and video of every vehicle involved in the crash, the scene of the crash, and anyone who stopped at the scene.
- 4.** Get the other driver's information, including their name, contact information, and insurance information.
- 5.** Get the names, telephone numbers, and addresses of all witnesses and other people who came to the scene. Do not rely solely on the police report for witness information.
- 6.** Contact your insurance company within 24 hours of the accident. Do not provide a recorded statement until you have spoken with an attorney.

If you are injured, seek medical attention immediately and document all of your complaints of pain. Take photographs and video of all visible injuries and keep track of all medical bills and out-of-pocket expenses. Also, keep a journal or diary of your injuries and how they affect your daily life. Finally, do not speak with the other driver's insurance carrier about your injuries or how the accident occurred.

Frequently Asked Questions

When should I contact a lawyer after a car accident?
